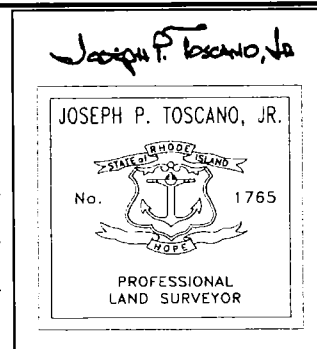

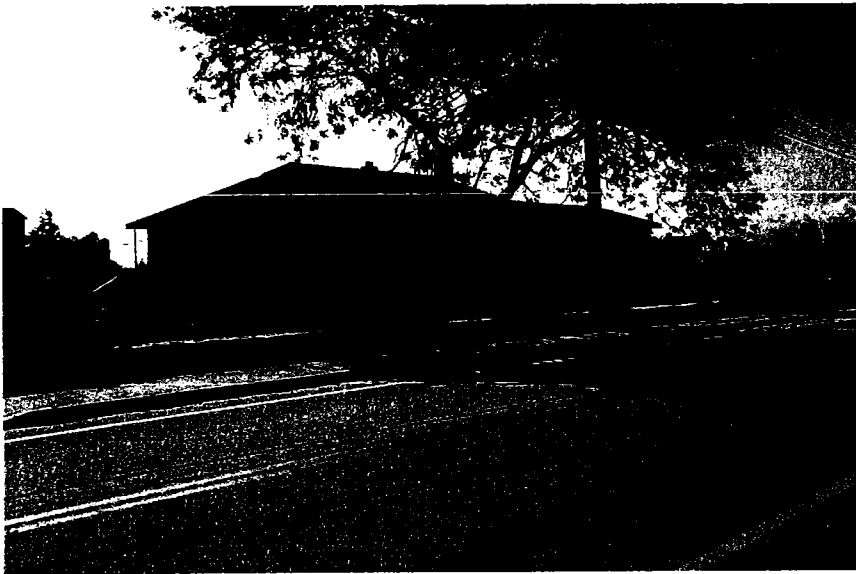
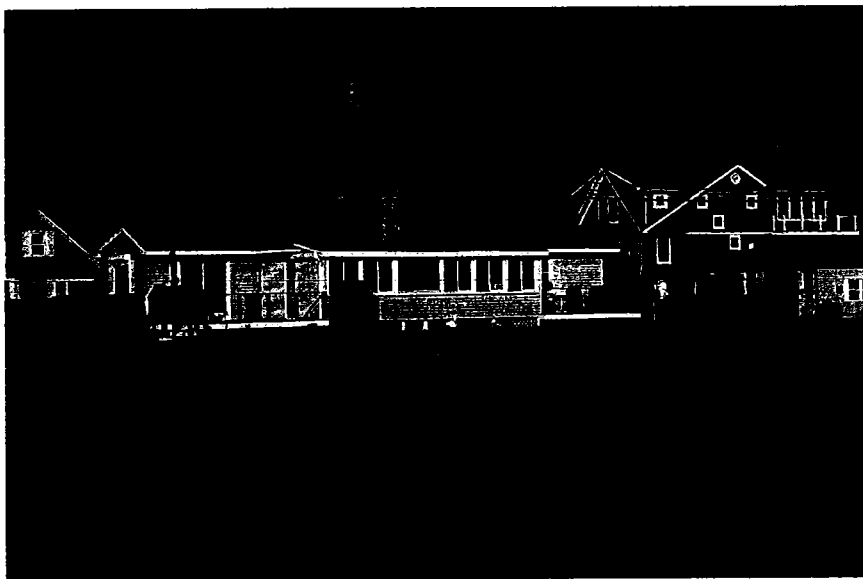


PHOTO 2: Taken 08/16/2013, From the opposite side of the waterway, "REAR & RIGHT SIDE house views.
