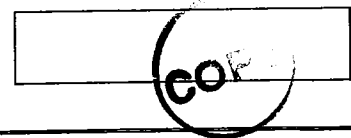

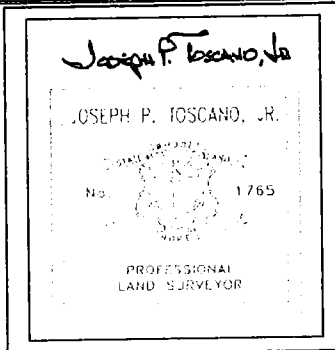

Comments The foundation type for the subject dwelling is concrete columns supporting the elevated floor with breakaway panels installed between the columns (See Photos) . The air conditioning exterior condenser is located on the rear deck at Elevation=12.9 feet, and is the lowest elevation of equipment servicing the dwelling. The remaining equipment and machinery servicing the subject dwelling are positioned on the elevated floors. The 196 sq. ft. enclosure area below the elevated floor is a stairway area from the concrete slab up to the elevated floor.

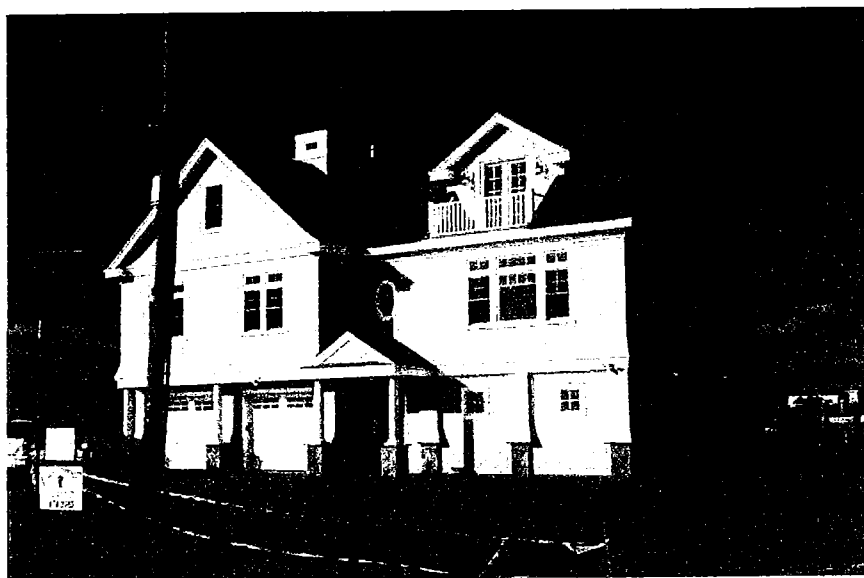


PHOTO 2: Taken 08/16/2013, From the street, looking at the "FRONT & LEFT SIDE" house views.
